#### 1. APOLOGIES FOR ABSENCE

#### 2. MINUTES OF THE LAST MEETING

The draft minutes of the Commons Committee meeting held on 19th July 2018 as circulated, were proposed by Cllr Hayward; seconded by Cllr Enticknap unanimously agreed as a true record for the Chairman to sign.

#### 3. MATTERS ARISING FROM THE MINUTES

Ref Item 6 - Cllr Enticknap and Gray met with officers from Waverley regarding the state of the paths. Waverley confirmed that they have no money available. Portfolio Holder Ken Deanus will lobby to find funding from elsewhere. Waverley confirmed that they are open to any changes that the Parish Council may want to make to the current lease. Clerk and Cllr Gray to work out the last 3 years of costs spent on the common.

#### 4. REPORT FROM THE CHAIRMAN OF THE COMMONS STEERING GROUP

Cllr Enticknap reported that the common has been cut. Willow trees have been removed from the School pond and the KGV pond. The last pond at the north end of the village has a an Ash tree that has died. It was AGREED that Cllr Enticknap would instruct Jo Court to remove the tree.

#### 5. LOCALISM PROGRAMME

Cllr Enticknap to provide the Clerk with quotes to be agreed with SCC in order to access the £3.5k funding available.

#### 6. WOODLAND AND POND MANAGEMENT PROGRAMME

Phase 2 to be arranged in Autumn. The track to the cricket pitch has still not been repaired.

#### 7. COMMON AREA ISSUES

The speed sign to the North of the village is still flashing. It had been agreed at the August meeting that the sign would be covered however after further discussion it was AGREED that Cllr Enticknap would disconnect the sign and repair the unrestricted speed sign.

There being no further business, the Chairman closed the meeting at 7.55pm.
