3. RATIFY COMMONS COMMITTEE MEETING

The Chairman reported on the proceedings of the Commons Committee meeting just held and it was RESOLVED to adopt the recommendations as recorded in the Commons Committee minutes.

A parishioner enquired if there were any significant changes made to the Neighbourhood Plan. The council explained that if there were significant changes that it would trigger another reg 14 consultation.

A parishioner asked when the Queens Platinum bench would be installed. The council confirmed that this would be done after March.

A parishioner enquired why there was no representative from the Parish Council at the Chennels Field appeal. The council had nothing further to add to the letter of objection that the inspector had seen and it's considered unhelpful if the council repeats what has already been acknowledged by the inspector.

A parishioner enquired if the council had put in any comments on the SCC bus consultation. The council replied that several of councillors had done so as individuals. Clerk to contact Cllr Kevin Deanus to request an extension.

A parishioner enquired when the bonfire from last November would be cleared away. Cllr Houghton to speak to the bonfire committee to have the remains cleared up.
